## **CONSULTATION ON FUTURE AFFILIATION TO NALC**

### **Welcome and Congratulations to all new and returning Councillors to Member Hampshire Parish and Town Councils.**

Like me, you will have just heard that the new Communities Secretary of State is Greg Clark MP. Read more about him at <https://www.gov.uk/government/people/greg-clark>. I am wondering how this will change National Policy direction of travel, if at all for parish and town councils?

I have also today, asked Michelle Leadbitter to forward to all member councils, a letter from the Chairman NALC to all new and returning parish and town councillors across England. Clerks will ensure that all councillors get the chance to read this note.

It is thus timely, and a good chance to ask you whether you – Hampshire local councils, should continue to affiliate to NALC? The decision will not be rushed, and if the ALC were to leave, then it would be effective as at 1<sup>st</sup> April 2017 – so this is very much the beginning of this two-year conversation.

### **Background**

Following communications from councils in 2014 that were dissatisfied with NALC, the ALC Board resolved on a draft resolution in November 2014, to give NALC a year's notice – this will be voted on in October 2015 – at our AGM. This resolution gives NALC a year's notice to improve or if not, notice of future disaffiliation. This resolution would then be revisited in AGM 2016 for final decision, to be effective 1<sup>st</sup> April 2017, in the worst case scenario. Timelines for consultation and voting were agreed at our GMC meeting of 30<sup>th</sup> April 2015.

### **Consultation**

I am now asking councils for their initial view, before our next General Management Committee meeting on 2<sup>nd</sup> July. Your answers might be Yes disaffiliate, Don't know yet, or No do not disaffiliate? In order to be able to discuss this, further information will be provided:
